7 Oklahoma Department of Veterans Affairs, the Oklahoma
8 Commission on Children and Youth, the Office of
9 Disability Concerns, the Department of Human
10 Services, the Office of Juvenile Affairs, the State
11 Department of Rehabilitation Services, the Oklahoma
12 Department of Agriculture, Food, and Forestry, the
13 Oklahoma Department of Commerce, the Rural Economic
14 Action Plan Fund, the Oklahoma Conservation
15 Commission, the Corporation Commission, the
16 Department of Environmental Quality, the Oklahoma
17 Historical Society, the J.M. Davis Memorial
18 Commission, the Department of Labor, the Department
19 of Mines, the Oklahoma Tourism and Recreation
20 Department, the Oklahoma Water Resources Board, the
21 Alcoholic Beverage Laws Enforcement Commission, the
22 Department of Corrections, the Oklahoma State Bureau
23 of Investigation, the Council on Law Enforcement
24 Education and Training, the Board of Medicolegal
Investigations, the Oklahoma State Bureau of
Narcotics and Dangerous Drugs Control, the Department
of Public Safety, the Office of the Attorney General,
the Court of Criminal Appeals, district attorneys and
the District Attorneys Council, the Supreme Court,
the Oklahoma Indigent Defense System, the Pardon and
Parole Board and the Special Cash Fund; stating
amounts of the appropriations; stating purposes and
restrictions; authorizing and requiring certain
expenditures; authorizing and requiring certain
transfers; providing for noncodification; and
providing effective dates.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the Oklahoma
Education Lottery Trust Fund from any monies not otherwise

1 appropriated from the Special Cash Fund of the State Treasury, the
2 sum of Ten Million One Hundred Forty-four Thousand One Hundred
3 Seventy-one Dollars (\$10,144,171.00) or so much thereof as may be
4 necessary pursuant to the provisions of Title 3A, Section 713(E) of
5 the Oklahoma Statutes.

6 SECTION 2. There is hereby appropriated to the State Board of
7 Education from any monies not otherwise appropriated from the
8 General Revenue Fund of the State Treasury for the fiscal year
9 ending June 30, 2018, the sum of One Billion Eighty-five Million
10 Four Hundred Seventy-four Thousand Five Hundred Eighty-six Dollars
11 (\$1,085,474,586.00) or so much thereof as may be necessary for the
12 financial support of public schools.

13 SECTION 3. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 Education Reform Revolving Fund created in Section 34.89 of Title 62
16 of the Oklahoma Statutes, the sum of Six Hundred Ninety-five Million
17 Four Hundred Seven Thousand One Hundred Thirty-eight Dollars
18 (\$695,407,138.00) or so much thereof as may be necessary for the
19 financial support of public schools.

20 SECTION 4. The State Board of Education is hereby authorized to
21 expend during the fiscal year ending June 30, 2018, from the Common
22 Education Technology Revolving Fund of the State Treasury, the sum
23 of Fifty Million Three Hundred Forty-three Thousand Fifty-seven
24

1 Dollars (\$50,343,057.00) or so much thereof as may be necessary for
2 the financial support of public schools.

3 SECTION 5. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Mineral Leasing Fund of the State Treasury for the fiscal year
6 ending June 30, 2018, the sum of Four Million Two Hundred Seventy-
7 five Thousand Dollars (\$4,275,000.00) or so much thereof as may be
8 necessary for the financial support of public schools.

9 SECTION 6. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 Mineral Leasing Fund of the State Treasury for the fiscal year
12 ending June 30, 2016, the sum of Two Million Six Hundred Twenty-four
13 Thousand Thirty-eight Dollars (\$2,624,038.00) or so much thereof as
14 may be necessary for the financial support of public schools.

15 SECTION 7. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2018, the sum of Twenty-one Million
19 Three Hundred Seventy-five Thousand Thirty-three Dollars
20 (\$21,375,033.00) or so much thereof as may be necessary for the
21 financial support of public schools.

22 SECTION 8. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2016, the sum of Nine Million Nine
2 Hundred Ninety-four Thousand Seven Hundred Fifteen Dollars
3 (\$9,994,715.00) or so much thereof as may be necessary for the
4 financial support of public schools.

5 SECTION 9. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2018, the sum of Ninety-two Million Two Hundred
9 Eighty-one Thousand Dollars (\$92,281,000.00) or so much thereof as
10 may be necessary for the support of public schools activities.

11 SECTION 10. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 General Revenue Fund of the State Treasury for the fiscal year
14 ending June 30, 2018, the sum of Two Hundred Ninety-nine Million
15 Three Hundred Twenty Thousand Three Hundred Forty Dollars
16 (\$299,320,340.00) or so much thereof as may be necessary for the
17 Certified Employee Health Benefit Allowance.

18 SECTION 11. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2018, the sum of One Hundred Sixty-three Million
22 Three Hundred Seventy-five Thousand Six Hundred Twenty-seven Dollars
23 (\$163,375,627.00) or so much thereof as may be necessary for Support
24 Personnel Health Benefit Allowance.

1 SECTION 12. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2018, the sum of Fifteen Million Six Hundred Eighty-
5 six Thousand Eight Hundred Thirty-four Dollars (\$15,686,834.00) or
6 so much thereof as may be necessary for administrative and support
7 functions of the State Department of Education.

8 SECTION 13. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the
11 fiscal year ending June 30, 2018, the sum of Two Million Three
12 Hundred Seventy-five Thousand Three Dollars (\$2,375,003.00) or so
13 much thereof as may be necessary for transfer to the School
14 Consolidation Assistance Fund.

15 SECTION 14. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2016, the sum of One Million One Hundred
19 Ten Thousand Five Hundred Twenty-seven Dollars (\$1,110,527.00) or so
20 much thereof as may be necessary for transfer to the School
21 Consolidation Assistance Fund.

22 SECTION 15. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2018, the sum of Two Million Three
2 Hundred Seventy-five Thousand Three Dollars (\$2,375,003.00) or so
3 much thereof as may be necessary for transfer to the Teachers'
4 Retirement System Dedicated Revenue Revolving Fund.

5 SECTION 16. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 Oklahoma Education Lottery Trust Fund of the State Treasury for the
8 fiscal year ending June 30, 2016, the sum of Nine Hundred Sixty-one
9 Thousand Seventy-nine Dollars (\$961,079.00) or so much thereof as
10 may be necessary for transfer to the Teachers' Retirement System
11 Dedicated Revenue Revolving Fund.

12 SECTION 17. There is hereby appropriated to the State Board of
13 Education from any monies not otherwise appropriated from the
14 Oklahoma Education Lottery Trust Fund of the State Treasury the sum
15 of One Hundred Forty-nine Thousand Four Hundred Forty-eight Dollars
16 (\$149,448.00) or so much thereof as may be necessary for transfer to
17 the Teachers' Retirement System Dedicated Revenue Revolving Fund.

18 SECTION 18. Notwithstanding any other provision of law, the
19 State Board of Education is hereby authorized to expend during the
20 fiscal year ending June 30, 2018, from the School Consolidation
21 Assistance Fund (260 Fund), the sum of Two Million Dollars
22 (\$2,000,000.00) or so much thereof as may be necessary to perform
23 the duties imposed upon the State Board of Education by law.

24

1 SECTION 19. There is hereby appropriated to the Oklahoma Arts
2 Council from any monies not otherwise appropriated from the General
3 Revenue Fund of the State Treasury for the fiscal year ending June
4 30, 2018, the sum of Two Million Six Hundred Sixty-nine Thousand
5 Seven Hundred Eighteen Dollars (\$2,669,718.00) or so much thereof as
6 may be necessary to perform the duties imposed upon the Oklahoma
7 Arts Council by law.

8 SECTION 20. There is hereby appropriated to the State Board of
9 Career and Technology Education from any monies not otherwise
10 appropriated from the General Revenue Fund of the State Treasury for
11 the fiscal year ending June 30, 2018, the sum of One Hundred Three
12 Million One Hundred Thirty-one Thousand One Hundred Ninety-four
13 Dollars (\$103,131,194.00) or so much thereof as may be necessary to
14 perform the duties imposed upon the State Board of Career and
15 Technology Education by law.

16 SECTION 21. There is hereby appropriated to the State Board of
17 Career and Technology Education from any monies not otherwise
18 appropriated from the Oklahoma Education Lottery Trust Fund of the
19 State Treasury for the fiscal year ending June 30, 2018, the sum of
20 Two Million Six Hundred Twelve Thousand Five Hundred Four Dollars
21 (\$2,612,504.00) pursuant to paragraph 2 of subsection C of Section
22 713 of Title 3A of the Oklahoma Statutes for allocation by the State
23 Board of Career and Technology Education for the education and
24 general operating budgets of the institutions and for other

1 programs, construction, renovations or repairs administered by the
2 State Board of Career and Technology Education.

3 SECTION 22. There is hereby appropriated to the State Board of
4 Career and Technology Education from any monies not otherwise
5 appropriated from the Oklahoma Education Lottery Trust Fund of the
6 State Treasury the sum of One Million Two Hundred Twenty-one
7 Thousand Five Hundred Eighty Dollars (\$1,221,580.00) pursuant to
8 paragraph 2 of subsection C of Section 713 of Title 3A of the
9 Oklahoma Statutes for allocation by the State Board of Career and
10 Technology Education for the education and general operating budgets
11 of the institutions and for other programs, construction,
12 renovations or repairs administered by the State Board of Career and
13 Technology Education.

14 SECTION 23. Notwithstanding any other provision of law, the
15 State Board of Career and Technology Education is hereby authorized
16 to expend during the fiscal year ending June 30, 2018, from the
17 State Board of Career and Technology Education Revolving Fund (200
18 Fund), the sum of Five Hundred Thousand Dollars (\$500,000.00) or so
19 much thereof as may be necessary to perform the duties imposed upon
20 the State Board of Career and Technology Education by law.

21 SECTION 24. There is hereby appropriated to the Office of
22 Educational Quality and Accountability from any monies not otherwise
23 appropriated from the General Revenue Fund of the State Treasury for
24 the fiscal year ending June 30, 2018, the sum of One Million Five

1 Hundred Twenty-seven Thousand Eighty Dollars (\$1,527,080.00) or so
2 much thereof as may be necessary to perform the duties imposed upon
3 the Office of Educational Quality and Accountability by law.

4 SECTION 25. There is hereby appropriated to the Oklahoma
5 Educational Television Authority from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2018, the sum of Two Million Five
8 Hundred Seventy-eight Thousand Seven Hundred Forty-one Dollars
9 (\$2,578,741.00) or so much thereof as may be necessary to perform
10 the duties imposed upon the Oklahoma Educational Television
11 Authority by law.

12 SECTION 26. There is hereby appropriated to the Oklahoma State
13 Regents for Higher Education from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2018, the sum of Five Hundred
16 Ninety-three Million Eight Hundred Seventy-eight Thousand Three
17 Hundred Ninety-one Dollars (\$593,878,391.00) so much thereof as may
18 be necessary for allocation by the Oklahoma State Regents for Higher
19 Education pursuant to the provisions of Article XIII-a of the
20 Oklahoma Constitution for the education and general operating
21 budgets of the institutions and for other programs, construction,
22 renovations or repairs administered by the Oklahoma State Regents
23 for Higher Education. Of those funds appropriated, the sum of Three
24 Million Dollars (\$3,000,000.00) shall be transferred to the Oklahoma

1 Tuition Equalization Grant Trust Fund to implement the provisions of
2 the Oklahoma Tuition Equalization Grant Act.

3 SECTION 27. There is hereby appropriated to the Oklahoma State
4 Regents for Higher Education from any monies not otherwise
5 appropriated from the Special Cash Fund of the State Treasury, the
6 sum of Fifteen Million Dollars (\$15,000,000.00) or so much thereof
7 as may be necessary to perform the duties imposed upon the State
8 Election Board by law.

9 SECTION 28. The Oklahoma State Regents for Higher Education are
10 hereby authorized to expend during the fiscal year ending June 30,
11 2018, the sum of Fifty Million Three Hundred Forty-three Thousand
12 Fifty-seven Dollars (\$50,343,057.00) from the Higher Education
13 Capital Revolving Fund of the State Treasury for allocation by the
14 Oklahoma State Regents for Higher Education pursuant to the
15 provisions of Article XIII-a of the Oklahoma Constitution for the
16 education and general operating budgets of the institutions and for
17 other programs, construction, renovations or repairs administered by
18 the Oklahoma State Regents for Higher Education.

19 SECTION 29. The Oklahoma State Regents for Higher Education are
20 hereby authorized to expend during the fiscal year ending June 30,
21 2018, the sum of Fifty Million Three Hundred Forty-three Thousand
22 Fifty-seven Dollars (\$50,343,057.00) from the Oklahoma Student Aid
23 Revolving Fund of the State Treasury for allocation by the Oklahoma
24 State Regents for Higher Education pursuant to the provisions of

1 Article XIII-a of the Oklahoma Constitution for the education and
2 general operating budgets of the institutions and for other
3 programs, construction, renovations or repairs administered by the
4 Oklahoma State Regents for Higher Education.

5 SECTION 30. There is hereby appropriated to the Oklahoma State
6 Regents for Higher Education from any monies not otherwise
7 appropriated from the General Revenue Fund of the State Treasury for
8 the fiscal year ending June 30, 2018, the sum of One Million Twenty-
9 seven Thousand Four Hundred Fifty Dollars (\$1,027,450.00) or so much
10 thereof as may be necessary for expenditures for concurrent
11 enrollment pursuant to Section 628.13 of Title 70 of the Oklahoma
12 Statutes.

13 SECTION 31. There is hereby appropriated to the Oklahoma State
14 Regents for Higher Education from any monies not otherwise
15 appropriated from the Oklahoma Education Lottery Trust Fund of the
16 State Treasury for the fiscal year ending June 30, 2018, the sum of
17 Eighteen Million Seven Hundred Sixty-two Thousand Five Hundred
18 Twenty-nine Dollars (\$18,762,529.00) pursuant to paragraph 2 of
19 subsection C of Section 713 of Title 3A of the Oklahoma Statutes for
20 allocation by the Oklahoma State Regents for Higher Education
21 pursuant to the provisions of Article XIII-a of the Oklahoma
22 Constitution for construction, renovations or repairs administered
23 by the Oklahoma State Regents for Higher Education or for any other
24

1 purpose authorized by paragraph 2 of subsection C of Section 713 of
2 Title 3A of the Oklahoma Statutes.

3 SECTION 32. There is hereby appropriated to the Oklahoma State
4 Regents for Higher Education from any monies not otherwise
5 appropriated from the Oklahoma Education Lottery Trust Fund of the
6 State Treasury the sum of Eight Million Seven Hundred Seventy-three
7 Thousand One Hundred Forty-three Dollars (\$8,773,143.00) pursuant to
8 paragraph 2 of subsection C of Section 713 of Title 3A of the
9 Oklahoma Statutes for allocation by the Oklahoma State Regents for
10 Higher Education pursuant to the provisions of Article XIII-a of the
11 Oklahoma Constitution for construction, renovations or repairs
12 administered by the Oklahoma State Regents for Higher Education or
13 for any other purpose authorized by paragraph 2 of subsection C of
14 Section 713 of Title 3A of the Oklahoma Statutes.

15 SECTION 33. There is hereby appropriated to the Oklahoma State
16 Regents for Higher Education from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2018, the sum of Three Million Five
19 Hundred Seventy-four Thousand Eight Hundred Seventy-four Dollars
20 (\$3,574,874.00) or so much thereof as may be necessary for the
21 general operating budget of the Administrative Offices of the
22 Oklahoma State Regents for Higher Education.

23 SECTION 34. There is hereby appropriated to the Commissioners
24 of the Land Office from any monies not otherwise appropriated from

1 the Commissioners of the Land Office Fund of the State Treasury for
2 the fiscal year ending June 30, 2018, the sum of Eight Million Five
3 Hundred Thirty-eight Thousand Six Hundred Dollars (\$8,538,600.00) or
4 so much thereof as may be necessary to perform the duties imposed
5 upon the Commissioners of the Land Office by law.

6 SECTION 35. There is hereby appropriated to the Oklahoma
7 Department of Libraries from any monies not otherwise appropriated
8 from the General Revenue Fund of the State Treasury for the fiscal
9 year ending June 30, 2018, the sum of Four Million One Hundred
10 Eighty-nine Thousand Eight Hundred Seventy-nine Dollars
11 (\$4,189,879.00) or so much thereof as may be necessary to perform
12 the duties imposed upon the Oklahoma Department of Libraries by law.

13 SECTION 36. There is hereby appropriated to the Physician
14 Manpower Training Commission from any monies not otherwise
15 appropriated from the General Revenue Fund of the State Treasury for
16 the fiscal year ending June 30, 2018, the sum of Two Million Seven
17 Hundred Sixty-six Thousand Fifty-two Dollars (\$2,766,052.00) or so
18 much thereof as may be necessary to perform the duties imposed upon
19 the Physician Manpower Training Commission by law.

20 SECTION 37. There is hereby appropriated to the Physician
21 Manpower Training Commission from any monies not otherwise
22 appropriated from the Special Cash Fund of the State Treasury the
23 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
24

1 thereof as may be necessary to perform the duties imposed upon the
2 Physician Manpower Training Commission by law.

3 SECTION 38. There is hereby appropriated to the Board of
4 Trustees of the Oklahoma School of Science and Mathematics from any
5 monies not otherwise appropriated from the General Revenue Fund of
6 the State Treasury for the fiscal year ending June 30, 2018, the sum
7 of Five Million Eight Hundred Fifty-five Thousand Eight Hundred
8 Eleven Dollars (\$5,855,811.00) or so much thereof as may be
9 necessary to perform the duties imposed upon the Board of Trustees
10 of the Oklahoma School of Science and Mathematics by law.

11 SECTION 39. There is hereby appropriated to the Oklahoma Center
12 for the Advancement of Science and Technology from any monies not
13 otherwise appropriated from the General Revenue Fund of the State
14 Treasury for the fiscal year ending June 30, 2018, the sum of Twelve
15 Million Eight Hundred Twenty Thousand Four Hundred Three Dollars
16 (\$12,820,403.00) or so much thereof as may be necessary to perform
17 the duties imposed upon the Oklahoma Center for the Advancement of
18 Science and Technology by law. Of those funds appropriated, the sum
19 of Five Hundred Nineteen Thousand Two Hundred Fifty-three Dollars
20 (\$519,253.00) shall be deposited in the Research Support Revolving
21 Fund, created pursuant to Section 5060.11 of Title 74 of the
22 Oklahoma Statutes. Of those funds appropriated, the sum of Two
23 Million Eight Hundred Fifty-five Thousand Eight Hundred Ninety-three
24 Dollars (\$2,855,893.00) shall be deposited in the Seed-capital

1 Revolving Fund, created pursuant to Section 5060.21 of Title 74 of
2 the Oklahoma Statutes.

3 GENERAL GOVERNMENT AND TRANSPORTATION

4 SECTION 40. There is hereby appropriated to the Office of the
5 State Auditor and Inspector from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2018, the sum of Two Million Nine
8 Hundred Ninety-one Thousand Two Hundred Fifty-three Dollars
9 (\$2,991,253.00) or so much thereof as may be necessary to perform
10 the duties imposed upon the Office of the State Auditor and
11 Inspector by law.

12 SECTION 41. There is hereby appropriated to the Office of the
13 State Auditor and Inspector from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2018, the sum of Two Hundred Sixteen
16 Thousand Five Hundred Seventeen Dollars (\$216,517.00) or so much
17 thereof as may be necessary to perform the duties imposed upon the
18 Commission on County Government Personnel Education and Training.
19 The appropriation made in this section shall be expended exclusively
20 for the purpose so stated and shall not be transferable.

21 SECTION 42. Notwithstanding any other provision of law, the
22 Office of the State Auditor and Inspector is hereby authorized to
23 expend during the fiscal year ending June 30, 2018, from the State
24 Auditor and Inspector Revolving Fund (200 Fund), the sum of One

1 Hundred Thousand Dollars (\$100,000.00) or so much thereof as may be
2 necessary to perform the duties imposed upon the Office of the State
3 Auditor and Inspector by law.

4 SECTION 43. There is hereby appropriated to the State Election
5 Board from any monies not otherwise appropriated from the General
6 Revenue Fund of the State Treasury for the fiscal year ending June
