12 expenses of various agencies of the executive,  
13 legislative and judicial departments of the state;  
14 making appropriations to the State Board of  
15 Education, the Oklahoma Arts Council, the State Board

17 Educational Quality and Accountability, the Oklahoma

10 Affairs, the State Department of Rehabilitation  
11 Services, the Oklahoma Department of Agriculture,  
12 Food, and Forestry, the Oklahoma Department of  
13 Commerce, the Rural Economic Action Plan Fund, the  
14 Oklahoma Conservation Commission, the Corporation  
15 Commission, the Department of Environmental Quality,  
16 the Oklahoma Historical Society, the J.M. Davis  
17 Memorial Commission, the Department of Labor, the  
18 Department of Mines, the Oklahoma Tourism and  
19 Recreation Department, the Oklahoma Water Resources  
20 Board, the Alcoholic Beverage Laws Enforcement  
21 Commission, the Department of Corrections, the  
22 Oklahoma State Bureau of Investigation, the Council  
23 on Law Enforcement Education and Training, the Board  
24 of Medicolegal Investigations, the Oklahoma State  
Bureau of Narcotics and Dangerous Drugs Control, the  
Department of Public Safety, the Court of Criminal  
Appeals, district attorneys and the District  
Attorneys Council, the Supreme Court, the Oklahoma  
Indigent Defense System, the Pardon and Parole Board,  
the Oklahoma Quick Action Closing Fund and the State  
Emergency Fund; stating amounts of the  
appropriations; stating purposes and restrictions;  
reappropriating certain funds; authorizing transfers  
and deposits; repealing Sections 1 through 18 of  
Enrolled House Bill No. 3705 of the 2nd Session of  
the 56th Oklahoma Legislature, which relate to the  
State Board of Education funding; repealing Sections  
2 and 3 of Enrolled House Bill No. 1022XX of the 2nd  
Extraordinary Session of the 56th Oklahoma  
Legislature, which relate to Oklahoma Health Care  
Authority funding; and providing effective dates.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 EDUCATION

3 SECTION 1. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2019, the sum of One Billion Three Hundred Seventy-  
7 three Million Two Hundred One Thousand Three Hundred One Dollars  
8 (\$1,373,201,301.00) or so much thereof as may be necessary for the  
9 financial support of public schools. Of those funds appropriated,  
10 the State Board of Education shall designate adequate amounts for  
11 increased compensation for certified personnel as provided in the  
12 provisions of Enrolled House Bill No. 1023 of the 2nd Extraordinary  
13 Session of the 56th Oklahoma Legislature, and for increased  
14 compensation for support employees as provided in the provisions of  
15 Enrolled House Bill No. 1026 of the 2nd Extraordinary Session of the  
16 56th Oklahoma Legislature.

17 SECTION 2. There is hereby appropriated to the State Board of  
18 Education from any monies not otherwise appropriated from the  
19 Education Reform Revolving Fund created in Section 34.89 of Title 62  
20 of the Oklahoma Statutes, the sum of Eight Hundred Eighteen Million  
21 One Hundred Sixty-six Thousand Nine Hundred Seventy-six Dollars  
22 (\$818,166,976.00) or so much thereof as may be necessary for the  
23 financial support of public schools.

1 SECTION 3. The State Board of Education is hereby authorized to  
2 expend during the fiscal year ending June 30, 2019, from the Common  
3 Education Technology Revolving Fund of the State Treasury, the sum  
4 of Fifty Million Four Hundred Seventy Thousand Seven Hundred Fifty-  
5 one Dollars (\$50,470,751.00) or so much thereof as may be necessary  
6 for the financial support of public schools.

7 SECTION 4. There is hereby appropriated to the State Board of  
8 Education from any monies not otherwise appropriated from the  
9 Mineral Leasing Fund of the State Treasury for the fiscal year  
10 ending June 30, 2019, the sum of Two Million Eight Hundred Fifty  
11 Thousand Dollars (\$2,850,000.00) or so much thereof as may be  
12 necessary for the financial support of public schools.

13 SECTION 5. There is hereby appropriated to the State Board of  
14 Education from any monies not otherwise appropriated from the  
15 Mineral Leasing Fund of the State Treasury for the fiscal year  
16 ending June 30, 2017, the sum of Two Hundred Ten Thousand Nine  
17 Hundred Eighty-four Dollars (\$210,984.00) or so much thereof as may  
18 be necessary for the financial support of public schools.

19 SECTION 6. There is hereby appropriated to the State Board of  
20 Education from any monies not otherwise appropriated from the  
21 Mineral Leasing Fund of the State Treasury for the fiscal year  
22 ending June 30, 2015, the sum of Nine Hundred Nine Thousand Nine  
23 Hundred Four Dollars (\$909,904.00) or so much thereof as may be  
24 necessary for the financial support of public schools.

1 SECTION 7. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
4 fiscal year ending June 30, 2019, the sum of Thirty Million Three  
5 Hundred Twenty-six Thousand Seven Hundred Thirty-five Dollars  
6 (\$30,326,735.00) or so much thereof as may be necessary for the  
7 financial support of public schools.

8 SECTION 8. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
11 fiscal year ending June 30, 2017, the sum of One Million Nine  
12 Hundred Eighty-five Thousand Six Hundred Thirty-eight Dollars  
13 (\$1,985,638.00) or so much thereof as may be necessary for the  
14 financial support of public schools.

15 SECTION 9. There is hereby appropriated to the State Board of  
16 Education from any monies not otherwise appropriated from the  
17 General Revenue Fund of the State Treasury for the fiscal year  
18 ending June 30, 2019, the sum of Ninety-one Million Three Hundred  
19 Nineteen Thousand Twenty-six Dollars (\$91,319,026.00) or so much  
20 thereof as may be necessary for the support of public schools  
21 activities.

22 SECTION 10. There is hereby appropriated to the State Board of  
23 Education from any monies not otherwise appropriated from the  
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2019, the sum of Thirty-three Million Dollars  
2 (\$33,000,000.00) or so much thereof as may be necessary for the  
3 purchase of textbooks and instructional materials.

4 SECTION 11. There is hereby appropriated to the State Board of  
5 Education from any monies not otherwise appropriated from the  
6 General Revenue Fund of the State Treasury for the fiscal year  
7 ending June 30, 2019, the sum of Three Hundred Fifteen Million Four  
8 Hundred Seventy-eight Thousand Thirty Dollars (\$315,478,030.00) or  
9 so much thereof as may be necessary for the Certified Employee  
10 Health Benefit Allowance.

11 SECTION 12. There is hereby appropriated to the State Board of  
12 Education from any monies not otherwise appropriated from the  
13 General Revenue Fund of the State Treasury for the fiscal year  
14 ending June 30, 2019, the sum of One Hundred Seventy-one Million  
15 Nine Hundred Five Thousand Eighty-six Dollars (\$171,905,086.00) or  
16 so much thereof as may be necessary for the Support Personnel Health  
17 Benefit Allowance.

18 SECTION 13. There is hereby appropriated to the State Board of  
19 Education from any monies not otherwise appropriated from the  
20 General Revenue Fund of the State Treasury for the fiscal year  
21 ending June 30, 2019, the sum of Fifteen Million Nine Hundred Eighty  
22 Thousand One Hundred Ninety Dollars (\$15,980,190.00) or so much  
23 thereof as may be necessary for administrative and support functions  
24 of the State Department of Education.

1 SECTION 14. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
4 fiscal year ending June 30, 2019, the sum of Three Million Three  
5 Hundred Sixty-nine Thousand Six Hundred Thirty-seven Dollars  
6 (\$3,369,637.00) or so much thereof as may be necessary for transfer  
7 to the School Consolidation Assistance Fund.

8 SECTION 15. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
11 fiscal year ending June 30, 2017, the sum of Two Hundred Twenty  
12 Thousand Six Hundred Twenty-six Dollars (\$220,626.00) or so much  
13 thereof as may be necessary for transfer to the School Consolidation  
14 Assistance Fund.

15 SECTION 16. There is hereby appropriated to the State Board of  
16 Education from any monies not otherwise appropriated from the  
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
18 fiscal year ending June 30, 2019, the sum of Three Million Three  
19 Hundred Sixty-nine Thousand Six Hundred Thirty-seven Dollars  
20 (\$3,369,637.00) or so much thereof as may be necessary for transfer  
21 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

22 SECTION 17. There is hereby appropriated to the State Board of  
23 Education from any monies not otherwise appropriated from the  
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2017, the sum of Two Hundred Twenty  
2 Thousand Six Hundred Twenty-six Dollars (\$220,626.00) or so much  
3 thereof as may be necessary for transfer to the Teachers' Retirement  
4 System Dedicated Revenue Revolving Fund.

5 SECTION 18. There is hereby appropriated to the Oklahoma Arts  
6 Council from any monies not otherwise appropriated from the General  
7 Revenue Fund of the State Treasury for the fiscal year ending June  
8 30, 2019, the sum of Two Million Seven Hundred Ninety-nine Thousand  
9 Two Hundred Sixty-six Dollars (\$2,799,266.00) or so much thereof as  
10 may be necessary to perform the duties imposed upon the Oklahoma  
11 Arts Council by law.

12 SECTION 19. There is hereby appropriated to the State Board of  
13 Career and Technology Education from any monies not otherwise  
14 appropriated from the General Revenue Fund of the State Treasury for  
15 the fiscal year ending June 30, 2019, the sum of One Hundred Twenty  
16 Million Three Hundred Eighty-eight Thousand Three Hundred Seventy-  
17 one Dollars (\$120,388,371.00) or so much thereof as may be necessary  
18 to perform the duties imposed upon the State Board of Career and  
19 Technology Education by law.

20 SECTION 20. There is hereby appropriated to the State Board of  
21 Career and Technology Education from any monies not otherwise  
22 appropriated from the Oklahoma Education Lottery Trust Fund of the  
23 State Treasury for the fiscal year ending June 30, 2019, the sum of  
24 Three Million Seven Hundred Six Thousand Six Hundred One Dollars



1 (\$3,706,601.00) pursuant to paragraph 2 of subsection C of Section  
2 713 of Title 3A of the Oklahoma Statutes for allocation by the State  
3 Board of Career and Technology Education for the education and  
4 general operating budgets of the institutions and for other  
5 programs, construction, renovations or repairs administered by the  
6 State Board of Career and Technology Education.

7 SECTION 21. There is hereby appropriated to the State Board of  
8 Career and Technology Education from any monies not otherwise  
9 appropriated from the Oklahoma Education Lottery Trust Fund of the  
10 State Treasury for the fiscal year ending June 30, 2017, the sum of  
11 Two Hundred Forty-two Thousand Six Hundred Eighty-nine Dollars  
12 (\$242,689.00) pursuant to paragraph 2 of subsection C of Section 713  
13 of Title 3A of the Oklahoma Statutes for allocation by the State  
14 Board of Career and Technology Education for the education and  
15 general operating budgets of the institutions and for other  
16 programs, construction, renovations or repairs administered by the  
17 State Board of Career and Technology Education.

18 SECTION 22. There is hereby appropriated to the Office of  
19 Educational Quality and Accountability from any monies not otherwise  
20 appropriated from the General Revenue Fund of the State Treasury for  
21 the fiscal year ending June 30, 2019, the sum of One Million One  
22 Hundred Twenty-four Thousand Seven Hundred Ninety-one Dollars  
23 (\$1,124,791.00) or so much thereof as may be necessary to perform  
24

1 the duties imposed upon the Office of Educational Quality and  
2 Accountability by law.

3 SECTION 23. There is hereby appropriated to the Office of  
4 Educational Quality and Accountability from any monies not otherwise  
5 appropriated from the Special Cash Fund of the State Treasury the  
6 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much  
7 thereof as may be necessary to perform the duties imposed upon the  
8 Office of Educational Quality and Accountability by law.

9 SECTION 24. There is hereby appropriated to the Oklahoma  
10 Educational Television Authority from any monies not otherwise  
11 appropriated from the General Revenue Fund of the State Treasury for  
12 the fiscal year ending June 30, 2019, the sum of Two Million Seven  
13 Hundred Seventy-nine Thousand Two Hundred Eighty-three Dollars  
14 (\$2,779,283.00) or so much thereof as may be necessary to perform  
15 the duties imposed upon the Oklahoma Educational Television  
16 Authority by law.

17 SECTION 25. There is hereby appropriated to the Oklahoma State  
18 Regents for Higher Education from any monies not otherwise  
19 appropriated from the General Revenue Fund of the State Treasury for  
20 the fiscal year ending June 30, 2019, the sum of Six Hundred Thirty-  
21 four Million Nine Hundred Sixty-eight Thousand Two Hundred Ninety  
22 Dollars (\$634,968,290.00) or so much thereof as may be necessary for  
23 allocation by the Oklahoma State Regents for Higher Education  
24 pursuant to the provisions of Article XIII-a of the Oklahoma

1 Constitution for the education and general operating budgets of the  
2 institutions and for other programs, construction, renovations or  
3 repairs administered by the Oklahoma State Regents for Higher  
4 Education. Of those funds appropriated, the sum of Three Million  
5 Twenty-four Thousand Six Hundred Forty-two Dollars (\$3,024,642.00)  
6 shall be transferred to the Oklahoma Tuition Equalization Grant  
7 Trust Fund to implement the provisions of the Oklahoma Tuition  
8 Equalization Grant Act.

9 SECTION 26. The Oklahoma State Regents for Higher Education are  
10 hereby authorized to expend during the fiscal year ending June 30,  
11 2019, the sum of Fifty Million Four Hundred Seventy Thousand Seven  
12 Hundred Fifty-one Dollars (\$50,470,751.00) from the Higher Education  
13 Capital Revolving Fund of the State Treasury for allocation by the  
14 Oklahoma State Regents for Higher Education pursuant to the  
15 provisions of Article XIII-a of the Oklahoma Constitution for the  
16 education and general operating budgets of the institutions and for  
17 other programs, construction, renovations or repairs administered by  
18 the Oklahoma State Regents for Higher Education.

19 SECTION 27. The Oklahoma State Regents for Higher Education are  
20 hereby authorized to expend during the fiscal year ending June 30,  
21 2019, the sum of Fifty Million Four Hundred Seventy Thousand Seven  
22 Hundred Fifty-one Dollars (\$50,470,751.00) from the Oklahoma Student  
23 Aid Revolving Fund of the State Treasury for allocation by the  
24 Oklahoma State Regents for Higher Education pursuant to the

1 provisions of Article XIII-a of the Oklahoma Constitution for the  
2 education and general operating budgets of the institutions and for  
3 other programs, construction, renovations or repairs administered by  
4 the Oklahoma State Regents for Higher Education.

5 SECTION 28. There is hereby appropriated to the Oklahoma State  
6 Regents for Higher Education from any monies not otherwise  
7 appropriated from the General Revenue Fund of the State Treasury for  
8 the fiscal year ending June 30, 2019, the sum of Eight Million Four  
9 Hundred Sixty-four Thousand Eight Hundred Twenty-three Dollars  
10 (\$8,464,823.00) or so much thereof as may be necessary for  
11 expenditures for concurrent enrollment pursuant to Section 628.13 of  
12 Title 70 of the Oklahoma Statutes.

13 SECTION 29. There is hereby appropriated to the Oklahoma State  
14 Regents for Higher Education from any monies not otherwise  
15 appropriated from the Oklahoma Education Lottery Trust Fund of the  
16 State Treasury for the fiscal year ending June 30, 2019, the sum of  
17 Twenty-six Million Six Hundred Twenty Thousand One Hundred Thirty-  
18 four Dollars (\$26,620,134.00) pursuant to paragraph 2 of subsection  
19 C of Section 713 of Title 3A of the Oklahoma Statutes for allocation  
20 by the Oklahoma State Regents for Higher Education pursuant to the  
21 provisions of Article XIII-a of the Oklahoma Constitution for  
22 construction, renovations or repairs administered by the Oklahoma  
23 State Regents for Higher Education or for any other purpose

1 authorized by paragraph 2 of subsection C of Section 713 of Title 3A  
2 of the Oklahoma Statutes.

3 SECTION 30. There is hereby appropriated to the Oklahoma State  
4 Regents for Higher Education from any monies not otherwise  
5 appropriated from the Oklahoma Education Lottery Trust Fund of the  
6 State Treasury for the fiscal year ending June 30, 2017, the sum of  
7 One Million Seven Hundred Forty-two Thousand Nine Hundred Forty-nine  
8 Dollars (\$1,742,949.00) pursuant to paragraph 2 of subsection C of  
9 Section 713 of Title 3A of the Oklahoma Statutes for allocation by  
10 the Oklahoma State Regents for Higher Education pursuant to the  
11 provisions of Article XIII-a of the Oklahoma Constitution for  
12 construction, renovations or repairs administered by the Oklahoma  
13 State Regents for Higher Education or for any other purpose  
14 authorized by paragraph 2 of subsection C of Section 713 of Title 3A  
15 of the Oklahoma Statutes.

16 SECTION 31. There is hereby appropriated to the Oklahoma State  
17 Regents for Higher Education from any monies not otherwise  
18 appropriated from the General Revenue Fund of the State Treasury for  
19 the fiscal year ending June 30, 2019, the sum of Three Million Nine  
20 Hundred Sixty-nine Thousand Four Hundred Sixty-nine Dollars  
21 (\$3,969,469.00) or so much thereof as may be necessary for the  
22 general operating budget of the Administrative Offices of the  
23 Oklahoma State Regents for Higher Education.

1 SECTION 32. There is hereby appropriated to the Commissioners  
2 of the Land Office from any monies not otherwise appropriated from  
3 the Commissioners of the Land Office Fund of the State Treasury for  
4 the fiscal year ending June 30, 2019, the sum of Eight Million Six  
5 Hundred Fifty-four Thousand Three Hundred Seventy-one Dollars  
6 (\$8,654,371.00) or so much thereof as may be necessary to perform  
7 the duties imposed upon the Commissioners of the Land Office by law.

8 SECTION 33. There is hereby appropriated to the Oklahoma  
9 Department of Libraries from any monies not otherwise appropriated  
10 from the General Revenue Fund of the State Treasury for the fiscal  
11 year ending June 30, 2019, the sum of Four Million Four Hundred  
12 Eighty-three Thousand Ten Dollars (\$4,483,010.00) or so much thereof  
13 as may be necessary to perform the duties imposed upon the Oklahoma  
14 Department of Libraries by law.

15 SECTION 34. There is hereby appropriated to the Physician  
16 Manpower Training Commission from any monies not otherwise  
17 appropriated from the General Revenue Fund of the State Treasury for  
18 the fiscal year ending June 30, 2019, the sum of Two Million Nine  
19 Hundred Thousand Seven Hundred Eighty-one Dollars (\$2,900,781.00) or  
20 so much thereof as may be necessary to perform the duties imposed  
21 upon the Physician Manpower Training Commission by law.

22 SECTION 35. There is hereby appropriated to the Physician  
23 Manpower Training Commission from any monies not otherwise  
24 appropriated from the Special Cash Fund of the State Treasury the

1 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much  
2 thereof as may be necessary to perform the duties imposed upon the  
3 Physician Manpower Training Commission by law.

4 SECTION 36. There is hereby appropriated to the Board of  
5 Trustees of the Oklahoma School of Science and Mathematics from any  
6 monies not otherwise appropriated from the General Revenue Fund of  
7 the State Treasury for the fiscal year ending June 30, 2019, the sum  
8 of Six Million Two Hundred Five Thousand Four Hundred Sixteen  
9 Dollars (\$6,205,416.00) or so much thereof as may be necessary to  
10 perform the duties imposed upon the Board of Trustees of the  
11 Oklahoma School of Science and Mathematics by law.

12 SECTION 37. There is hereby appropriated to the Oklahoma Center  
13 for the Advancement of Science and Technology from any monies not  
14 otherwise appropriated from the General Revenue Fund of the State  
15 Treasury for the fiscal year ending June 30, 2019, the sum of  
16 Thirteen Million Three Hundred Fifty-six Thousand Nine Hundred  
17 Twenty-seven Dollars (\$13,356,927.00) or so much thereof as may be  
18 necessary to perform the duties imposed upon the Oklahoma Center for  
19 the Advancement of Science and Technology by law. Of those funds  
20 appropriated, the sum of Five Million Three Hundred Thirty-three  
21 Thousand Five Hundred Forty-two Dollars (\$5,333,542.00) shall be  
22 deposited in the Research Support Revolving Fund, created pursuant  
23 to Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those  
24 funds appropriated, the sum of Two Million Nine Hundred Thirty-three

1 Thousand Four Hundred Forty-eight Dollars (\$2,933,448.00) shall be  
2 deposited in the Seed-capital Revolving Fund, created pursuant to  
3 Section 5060.21 of Title 74 of the Oklahoma Statutes.

4 GENERAL GOVERNMENT AND TRANSPORTATION

5 SECTION 38. There is hereby appropriated to the Office of the  
6 Attorney General from any monies not otherwise appropriated from the  
7 General Revenue Fund of the State Treasury for the fiscal year  
8 ending June 30, 2019, the sum of Nine Million Three Hundred Sixty-  
9 two Thousand Fifty-one Dollars (\$9,362,051.00) or so much thereof as  
10 may be necessary to perform the duties imposed upon the Office of  
11 the Attorney General by law.

12 SECTION 39. There is hereby appropriated to the Office of the  
13 Attorney General from any monies not otherwise appropriated from the  
14 General Revenue Fund of the State Treasury for the fiscal year  
15 ending June 30, 2019, the sum of Eight Hundred Ninety-nine Thousand
